

# ARTICLES OF INCORPORATION





The undersigned, acting as incorporators of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

## I. NAME OF CORPORATION:

The name of the Corporation is NORTH BON AIR NEIGHBORHOOD, INC.

### II. PRINCIPAL OFFICE:

The principal office of the Corporation is located at 3817 North A Street West, Tampa, FL 33609-2702.

### III. MAILING ADDRESS:

### IV. REGISTERED AGENT

### VIII. CORPORATE PURPOSES

This Corporation is formed to work for the social, economic, educational, cultural and physical betterment of the community generally known as the "North Bon Air" neighborhood in the City of Tampa, Florida. These purposes include, but are not limited to, the following:

- combatting community deterioration;
- protecting the integrity of the community by sponsoring efforts to reduce crime and juvenile delinquency;
- fostering interest in the betterment of the neighborhood among its residents;
- communicating the needs and concerns of the community to appropriate elected and appointed officials and agencies;
- promoting efforts to improve social and environmental conditions in the community;
- improving recreational opportunities for the residents of the community;
- working for the common good and general welfare of the residents of the community;
- engaging in any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations trusts, institutions, foundations, or governmental bureaus, departments or agencies.

### IX. ADMINISTRATION

The affairs of the Corporation shall be managed and conducted by its Board of Directors. The duties, quorum, terms of office and frequency of meetings of the Board of Directors shall be as set forth in the by-laws. All of the meetings of the Board of Directors shall be conducted in accord with Robert's Rules of Order so long as such rules do not conflict with the by-laws.

#### X. OFFICERS

Signature

The officers of the Corporation shall be President, Vice President, Secretary, Treasurer and any other officer prescribed in the Corporation's by-laws. Their manner of election, terms of office, and procedures for filling of vacancies shall be set forth in the by-laws.

### XI. INDEMNIFICATION

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he/she is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him/her (or by their heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his/her duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such Director or Officer (or such heirs, executors of administrators) may be entitled apart from this Article.
