Article V of The Articles of incorporation of Mothers' Voices of South Florida, Inc., a Florida Not-For-Profit Corporation, hereinafter referred to as the "Corporation," is amended to read as follows:

ARTICLE V. DEDICATION AND DISTRIBUTION OF ASSETS

No part of the net earnings of the Corporation shall inure to the benefit of any member, director or officer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes) and no member, director or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation.

Upon the dissolution of the organization, all property and assets shall be distributed to Mothers' Voices, Inc., a New York not-for-profit corporation, if in existence and if exempt under section 501(c)(3) of the Internal Revenue Code. If the named recipient is not in existence or not exempt under section 501(c)(3) of the Internal Revenue Code, all property and assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3), or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of the Court of Common Pleas of the county in which the principal office of the organization is then located,
