**ARTICLES OF INCORPORATION**  
**OF THE**  
**WES CHANDLER YOUTH FOUNDATION, INC**

We , the undersigned residents of the State of Florida, being eighteen (18) years or more of age, do hereby associate ourselves together for the purposes of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation is the **Wes Chandler Youth Foundation, Inc .**

**ARTICLE II**

**Statement of Corporate Nature**

This is a non-profit corporation organized solely for general charitable purposes pursuant to the Florida Corporations Not For Profit Act set forth in Chapter 617 of the Florida Statues.

**ARTICLE III**

**Address of Principle Office**

The address of the principle office and the mailing address of the corporation is as follows: 450 Whitney Street, Daytona Beach Florida 32114.

**ARTICLE IV**

**General and Specific Purposes**

- A. To motivate the youth of a community to learn, to stay in school, to complete one's education and to continue studying towards college or other advanced levels of education, either general or vocation or;
- B. To promote good health, good will, interest in participation in athletics and physical education
- C. To foster and encourage in the youth of the community a spirit of loyalty and faith in American traditions and institutions.

- D. To participate actively in constructive movements and endeavors for the promotion and safeguarding of the interest and general welfare of the youth of community.
- E. To promote the spirit of benevolence, friendship, sociability, good will and tolerance among the youth in the community.
- F. To perform any and all other lawful things incident and kindred to the above purposes and promote programs of youth activities.

## **ARTICLE V**

### **Membership**

Section 1. The Corporation shall have active members only.

Section 2. All persons of good character who are authorized shall be eligible for active membership.

Section 3. No person, otherwise eligible for membership, shall be denied membership in the **Wes Chandler Youth Foundation, INC.** because of sex, race, color, creed or nationality.

Section 4. Persons qualified as members shall be admitted in the following manner: By paying annual dues to the **Wes Chandler Youth Foundation, INC.** an amount and in the manner provided in the By-Laws.

## **ARTICLE IX**

### **By-Laws**

The initial By-Laws of the Corporation shall be adopted by the Board of Directors by majority vote. The power to alter, amend or repeal the By-Laws and to adopt new By-Laws shall be vested in the Board of Directors by majority vote unless otherwise provided for in the By-Laws.



## **ARTICLE X**

### **Amendment to Articles**

Amendments to the Articles of Incorporation shall be recommended by a majority vote of the Board of Directors to the membership, and adopted by a majority vote of all members present and entitled to vote at a duly called meeting of the membership.

## **ARTICLE XI**
