ARTICLES OF INCORPORATION OF THE FOOT SOLDIERS, INC.

We, the undersigned incorporators, hereby associate ourselves together to form and establish a corporation, NOT for profit under the laws of the State of Florida.

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following articles of Incorporation:

ARTICLE 1

The name of the corporation shall be:

ARTICLE II Principal place of business and mailing address

ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

The purpose of this Corporation is designed to enhance the opportunities that youngsters may otherwise be oblivious to. Students are encouraged to maintain a 2.7 minimum grade point up to the 10th grade, and from 10th through 12th grade must maintain a 3.0 G.P.A.. We teach them how a business works, as well as give them a chance to run a business of their own. We encourage them to funnel most of the earnings towards a bank account, which will go towards a college saving fund. A mentoring program is established which allows many participants to spend time with Leading Business Professionals who are working in the field that the students hope to one day enter. This early business exposure is priceless, as it gives the young students a chance to see the inner workings of the careers they have chosen to enter. Students are helped in the development of their professional appearance and presentation. Regular workshops are held to help them with their interviewing skills, oral presentations, and their dress for various occasions.

These drills build experience and confidence in the students. The students are taught to give back to the community where they live, either through a school organization, a special project or a church project. Their personal talents are enhanced by the opportunity to display at their creativity at least twice a year. Creativity is enhanced when others can be a part of experiencing it. This is for all race, creeds, religions and sexes, oriented to the organization principles.

ARTICLE IV Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The Corporation shall be managed by Board of Directors. The first Board of Directors are appointed by the Incorporators or named as the initial Board of Directors in the Certificate of Incorporation of the Corporation, and they shall hold office until the first Annual Meeting of Members, and until theirs successors have been duly elected and qualify. Thereafter at each Annual Meeting of Members, the membership shall elect directors to hold office until next Annual Meeting. Each wirector shall hold office until his successor has been duly elected and qualified.

ARTICLE V Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statues, unless limited as follows:

Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt, organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this organization shall not ca any activities not permitted to be carried on by an organization exempt from Feder Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
