

**ARTICLES OF INCORPORATION
OF

- ONE: The name and address of this principal corporation is DAVID ANDREWS MINISTRIES, INC., 455 Depot Ave, Delray Beach, Florida, 33447, Palm Beach County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes. To establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with The Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development programs, but shall not be limited to: Homelessness, Health Care, Child Care, Youth at High Risk, Tutorial, land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR: The address of the REGISTERED office is 455 Depot Ave, Delray Beach, Florida, 33447, Palm Beach County. And the name and address of the registered agent of the corporation shall be:

- (a) This corporation is organized and operated exclusively for Religious purposes within the meaning of 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.


FIVE: The Board of Trustees are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Trustees of this corporation are:

All articles or amendments of the corporation shall be terminated, if at any time be in conflict with the teaching of Jesus Christ. The above articles are in accordance with the 1st and 14th amendments of the U. S. Constitution.


