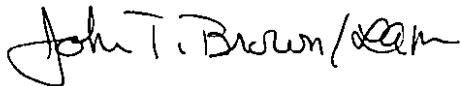

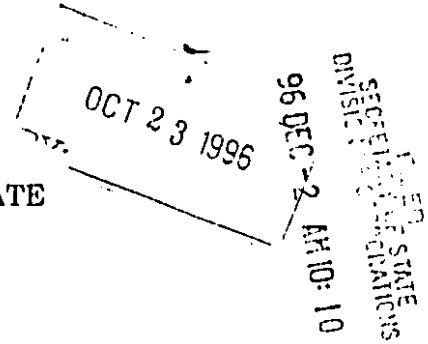

**ARTICLES OF INCORPORATION**

**BY THESE ARTICLES OF INCORPORATION** the incorporators form a not-for-profit corporation under the Florida law.

**ARTICLE I**

**CORPORATE NAME**

The name of this corporation is **S.W.A.T. TEAM MINISTRY, INC.**

**ARTICLE II**

**PURPOSES**

The purposes of **S.W.A.T. TEAM MINISTRY, INC.** is to provide guidance and services to the youth of Santa Rosa County and the surrounding communities for the betterment of the youth, including promotion of good moral conduct and character, guidance and seeking to fulfill the youths' spiritual needs.

This corporation shall exist perpetually.

**ARTICLE III**

**MEMBERS**

- (A) The members of this corporation shall be those who evidence an interest in furthering the purposes of the corporation, as those purposes are set forth in the Articles of Incorporation of the Corporation, and who are elected to the Corporation.
- (B) An individual becomes a member of this corporation after nomination by a current member of the Board of Directors of the Corporation and who has thereafter received the approval of a majority vote of the Board of Directors present at a meeting of the Board of Directors.
- (C) The method for selection of Directors of the Corporation and renewal of the terms of service is contained in the By-Laws of the Corporation.

## **ARTICLE IV**

### **STOCK**

This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. On the dissolution of this corporation the Board of Directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes, and that shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Code of 1954 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county where the principal office of this corporation is then located, exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.

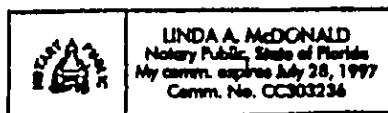
