ARTICLES OF INCORPORATION

A CORPORATION NOT FOR PROFIT

We the undersigned, desiring to associate for the purpose of incorporating as a corporation not for profit under the provisions of Chapter 617 of Florida Statutes, do hereby propose the following as our Articles of incorporation.

ARTICLE I

The name of this corporation is:

CROSS ROADS FREE METHODIST CHURCH, INC.

The address of this corporation is **1595 E Graves, Orange City, FL 32763**, or such other address within the State of Florida as the Board of Trustees may from time to time designate.

ARTICLE II

The general nature, objects and purposes for which this corporation is exclusively organized and operated are to promote the Christian religion, and to promote the doctrine and experiences of full salvation as set forth in the Book of Discipline of the Free Methodist Church. This corporation shall receive and maintain funds of real and/or personal property, and subject to the restrictions and limitations herein above and hereinafter set forth, use the whole or any part of the income therefrom and the principal thereof to do and perform all acts and things necessary for the proper conduct and management of the corporation.

ARTICLE III

The qualifications for membership and the election of trustees who shall be directors of the corporation shall be the same as the general rules and requirements for membership in the Free Methodist Church as set forth in the bylaws (Book of Discipline of the Free Methodist Church).

ARTICLE IV

The term for which this corporation is to exist shall be perpetual.

ARTICLE V

The corporation as it relates to real estate and personal property shall be subject to and governed by the Discipline of the said Free Methodist church, but the secular affairs of the said corporation shall be conducted, controlled and managed by a board of trustees, who shall be the directors of the said corporation, of not less than three, nor more than nine, elected each year, at the annual election, in accordance to the bylaws of the Book of Discipline of the Free Methodist Church. All deeds shall be made direct in the corporate name, and shall contain the trust clause found in paragraph A856 of the Book of Discipline of the Free Methodist Church.

ARTICLE VI

The name of the corporation's registered agent at the following address is **Thomas Lovett** and the street address of the corporation's registered office is, **2024 N. Normandy Blvd., Orange City, FL 32725**. The corporation shall keep the Department of State of the State of Florida informed of the current city, town, or village and street address of said registered office together with name of the registered agent.

ARTICLE VII

ARTICLE VIII

The bylaws of the corporation are to be made, altered or rescinded in accordance with the Book of Discipline of the Free Methodist Church .

ARTICLE IX

The highest amount of indebtedness or liability of said corporation may subject itself, shall never be greater than two-thirds of the value of property of the corporation, both real and personal and mixed.

ARTICLE X

The amount in value of the real estate which the corporation may hold, shall be one (1) million dollars, at all times subject to the approval of the Judge of the Circuit Court, in and for **Volusia County**, Florida.


