**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
JESUS PEOPLE LIFE CHANGING MINISTRIES CHURCH, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**1. AMENDMENTS ADOPTED:**

Article VII, Number 1, of the Articles of Incorporation of the corporation, is hereby amended to read as follows:

**ARTICLE VII**

1. "The offices held and the directors serving under the Articles of Incorporation will be:

The above named persons will constitute the official board of directors/trustees. The above named persons shall serve as members of the board of directors/trustee."

Article VII, Number 2, Section (5) of the Articles of Incorporation, is hereby amended with an addition to letter (a), to read as follows:

- (a) "...However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code (or corresponding of any future Federal tax code.)"

Article VIII, Conflict of Interest Policy, is hereby added to the Articles of Incorporation, to read as follows:

**ARTICLE VIII  
CONFLICT OF INTEREST POLICY**

"Any director, officer, or key employee who has an interest in a contract or other transaction presented to the Board or a committee thereof for authorization, approval, or ratification shall make a prompt and full disclosure of his interest to the Board or committee prior to its acting on such contract or transaction. Such disclosure shall include any relevant and material facts known to such person about the contract or transaction which might reasonably be construed to be adverse to the corporation's interest.

The body to which such disclosure is made shall thereupon determine, by a vote of seventy-five percent (75%) of the votes entitled to vote, whether the disclosure shows that a conflict of interest exists or can reasonably be construed to exist. If a conflict is deemed to exist, such person not vote on, nor use his personal influence on, nor participate (other than to present factual information or to respond to questions) in, the discussion or deliberations with respect to such contract or transaction. Such person may be counted in determining whether a quorum is present but may not be counted when the Board of Directors or a committee of the Board takes action on the transaction. The minutes of the meeting shall reflect the disclosure made, the vote thereon, the abstention from voting and participation, and whether a quorum was present."

2. The foregoing amendments were adopted on September 5, 1998.
3. The foregoing amendments were adopted by the members and the number of votes cast for the amendment was sufficient for approval.
