

Section 3. In the absence of a specific rule or rules covering the same, the recognized practices and rules of Conservative Christian schools shall control.

Section 4. E.V.A. will not discriminate against students based on race, religion or gender.

### ARTICLE 1

This school shall be known as Eagle's View Academy, Inc. of Jacksonville, Florida.

### ARTICLE 2

The principal place of business and the mailing address of this corporation shall be:

Jacksonville, FL 32221

Eagle's View Academy (to be referred to as E.V.A. from here on) exists for the exclusive purpose of providing an academic education which stresses Christian values based on the teaching of God's Word, the Bible. This corporation will stay within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

### ARTICLE 3

Section 1. For convenience in handling of its legal business matters, this school has been incorporated under the laws of the State of Florida as a corporation not for profit. It is not intended that any of its principles, doctrines or beliefs as a Christian school shall be hereby affected. Except as to those matters and things specifically required by the corporate charter or by-laws to be handled in another or different way--which matters and things when so required shall be so handled--these rules as hereinafter set forth shall govern and control all matters, actions, and affairs of the school, whenever applicable.

Section 2. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Section 3. The school shall abide by the rules and standards specifically covered in the most recent publication of the Eagle's View Academy Handbook.

Section 4. In the absence of a specific rule or rules covering the same, the recognized practices and rules of Conservative Christian schools shall control.

Section 5. The E.V.A. school admits students of any race, color, national, and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.


