ARTICLES OF INCORPORATION OF KIWANIS CLUB OF BONITA SPRINGS, FLORIDA, INC.

The undersigned, acting as incorporator of a corporation not for profit pursuant to chapter 617, Florida Statues, adopt the following Articles of Incorporation of such corporation.

ARTICLE I

The name of this corporation shall be KIWANIS CLUB OF BONITA SPRINGS, FLORIDA, INC. The street address of the initial principal office and the mailing address of this corporation shall be Kiwanis Club of Bonita Springs, Florida, Inc., c/o Gerald E. Ruttman, 528 Retreat Drive, #104, Bonita Springs, FL 33923.

The name and address of the incorporator is Robert W. McClure, Esq. 5121 Castello Drive, Suite Two, Naples, FL 34103.

ARTICLE II

The existence for this corporation shall be perpetual.

ARTICLE III

The purposes of the Kiwanis Club of Bonita Springs, Florida, Inc. are:

- 1. To give primacy to the human and spiritual rather than to the material values of life
- 2. To encourage the daily living of the Golden Rule in all human relationships
- 3. To promote the adoption and application of higher social, business, and professional standards.
- 4. To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
- 5. To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
- 6. To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism and goodwill.
- 7. For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Bonita Springs, and its members.
- 8. To do all such things as are incidental or conducive to the attainment of the above objects.

ARTICLE IV

The qualifications of members and the manner of their admissions shall be in accordance with the provisions set forth in the Bylaws.

ARTICLE Y
