ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation shall be:

ARTICLE III

Purposes

The specific purposes for which the corporation is organized are enumerated below.

The general nature of the business to be transacted and carried on by this corporation and its objects and purposes are to do any and all things hereinafter set out or provided and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon business corporations as fully and to the same extent as natural persons might or could do in all parts of the world, namely:

(1) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, consign, transfer or otherwise dispose of, and to invest in, trade in, deal in, and with, goods, wares, merchandise, real and personal property, and services of every class, kind, and

descriptions except that it is not to conduct a banking, safe deposit, trust, insurance, surety, cargo, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition;

(2) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and counties;

(3) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfer of corporate property, or other instruments to secure the payment of corporate indebtedness as required;

(4) To purchase the corporate assets of any other corporation and engage in the same and other character of business;

(5) To endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock;

(6) To become guarantor or surety for any other person, firm or corporation for any purpose or transaction whatsoever;

(7) To make gifts of its property or cash, either to charitable organizations or otherwise, when deemed in the interest of the company;

(8) To adopt such pension, profit sharing, stock option, and deferred compensation plans for officers, employees and directors and to grant such stock options to officers, employees, directors and others as the directors may deem to be in the interest of the company;

(9) To do all and everything necessary, suitable or proper for the accomplishment of any purposes or objects either alone or in association with other corporations, firms or individuals, to the same extent and as fully as natural persons might or could do as principals, agents, contractors, or otherwise;

(10) The foregoing shall be construed as both objects and powers. The enumeration of specific powers and purposes is not intended to restrict or limit in any way the powers or purposes of this corporation.
