## ARTICLES OF INCORPORATION OF UNITED BAPTIST CHURCH OF JACKSONVILLE, INC.

ARTICLE I

NAME

The name of the corporation shall be: United Baptist Church of Jacksonville, Inc.

ARTICLE II

PRINCIPAL OFFICE

The address of the principal office and the mailing address is: 296 Woodlawn Avenue, Jacksonville, Florida 32204.

ARTICLE III

**PURPOSE** 

The purpose for which the corporation is formed is exclusively for charitable, religious, or educational purposes.

ARTICLE IV

STRUCTURE OF ENTITY AND MEMBERSHIP

The corporation is not organized for profit; it shall have no capital stock and shall not be authorized to issue capital stock. In accordance with Florida Statutes, Chapter 617.013, membership in the corporation and other matters relating to its members shall be as set forth in the Bylaws of the corporation.

ARTICLE V

DURATION

The term for which the corporation shall exist shall be perpetual commencing on the date of filing of these Articles of Incorporation in the office of the Secretary of State.

ARTICLE VI

LIMITATION ON CORPORATE POWERS

In the administration of the corporation, the Board of Trustees shall have only delegated authority to act on the behalf of and in the best interest of the corporation. All recommendations from the Board of Trustees shall be subject to a majority vote by all corporate members

attending. It is intended that the corporation be entitled to exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code, as now in force or afterwards amended.

#### ARTICLE VII

#### MANAGING OFFICERS

The officers who will manage the affairs of the corporation shall be its Trustees. The number of Trustees on the Board shall be six (6), which number may be increased or decreased pursuant to the Bylaws of the corporation, but shall never be less than three (3). #### ARTICLE IX

#### **BYLAWS**

The power to adopt, alter, amend, repeal or rescind the Bylaws of the corporation shall be vested in the care of the Bylaw Committee. Any adoption or alteration to the Bylaws are subject to the approval of the corporation's members by a two-third (2/3) majority vote.

#### ARTICLE X

#### **AMENDMENT**

This corporation, through its members, reserve the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto. Amendments to these Articles of Incorporation may be proposed by any member of the church body or by any committee organized for that purpose through the form of a motion or recommendation and may be adopted by a two-third (2/3) majority vote of all members attending.
