Pursuant to Florida Statutes Section 617.1002, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:


1. Article One is hereby amended to read as follows:

2. The foregoing amendment was adopted by the affirmative vote of a majority of the members entitled to vote at a special meeting of members on August 23, 2006.



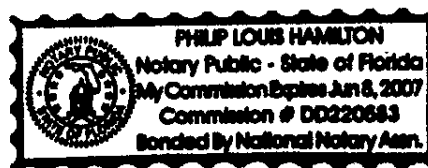
