AMENDING THE NRTICLE OF INCORPORATION OF REDEEMING FAITH MINISTRIES, INC.

AMENDING ARTICLE III PURPOSE(s) TO DELETE THE ORIGINAL STATEMENT AND INCLUDE THE FOLLOWING STATEMENT:

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

AMENDING ARTICLE V LIMITATION OF CORPORATE POWERS TO DELETE THE CAIGINAL STATEMENT AND INCLUDE THE FOLLOWING:

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

AMENDING ARTICLE TEN DISSOLUTION TO DELETE ORIGINAL STATEMENT AND INCLUDE THE FOLLOWING STATEMENT:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Interanl Recenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively of such purposes or to such organization, as said Court shall determine, which are organized and operated exclusively for such purposes.
