(A Corporation not for Profit)

We the undersigned, hereby associate ourselves together for the purposes of becoming incorporated under Chapter 617, Florida Statutes applicable to corporation not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the proposed Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be G'S ATHLETIC TESTING FACILITY., INC, and it's principle place of business shall be at 3028 1st Street West Bradenton, Florida 34205

ARTICLE II

PURPOSE

The general purpose of G'S Athletic Testing Facility.,INC, shall be to Educate, Evaluate and Enhance the physcial skills of persons. The facility will focus on and emphasize

A. Education

1. Tutoring- all academic areas
2. Computer Literacy
3. Speech (public speaking, Foreign Languages, guided interviews.

B. Social Service

- A. Provide services to assist clients
- B. Provide a sense of hope and help
- C. Seek to work closely with families
- D. To assist those who are dysfunctional after tragedy. We will offer guidance and counseling

1. G'S Athletic Testing Facility., INC will strive to improve the speed conditioning levels, strength, power and self- discipline of its participants. We will strive to help each person reach their fullest potential through hard work and proper training methods. The use of steroids or other drugs will not in anyway be advocated. We will always be positive, deal with issues in an adult manner and with maximum effort, develop individual attributes.
2. To assist each participant in becoming the best competitor that they can be. This program is designed to develop the physcial attributes to meet specific demands. Success of the program will be measured by a battery of test specific to the goals of the program and by performances in competition.
3. Parents will be invited and encouraged to become a part of the total program. G'S Athletic Testing Facility goals and expectations is a increase in academic success and a increase commitment to education as skills improve. Development of more appropriate and acceptable social behavior resulting in decreased suspensions, drop-outs and arrests. ARTICLE III

Membership

ARTICLE IV

Board of Directors

OFFICERS

Section I. Article VI

By-Laws

Section I. The Board of Directors shall have the right to make and adopt bylaws as they deem proper and advisable and such bylaws shall be made, altered or rescinded upon a two-third vote of the Board of Directors present and voting at any regular or special business meeting to the Board of Directors called for that purpose by the President as provided in the bylaws. Bylaws so prepared, altered or rescinded shall be submitted to the membership at a regular or special meeting for their approval or refusal.

Section II

For these purpose a Quorum shall consist of one-half of the members of the Board of Directors.

Article VII

Amendment of Articles of G's Athletic Testing
Facility

Amendment to the Article of G'S Athletic Testing Facility., INC may be amended, altered or repealed, and new articles may be adopted at any meeting of the Board of Directors by a vote of a majority or two-third vote of the Board of Directors, provided that written notice of any such proposed amendment or other change in the articles shall been given to the members of the Board of Directors at least ten (10) days prior to the meeting at which such action is contemplated.

Article VIII

Powers

G'S Athletic Testing Facility., INC powers are as provided in section 617 0302, Florida Statutes unless limited are as follows. This corporation is to have power to do any and all things necessary for carrying out the purpose, and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to the corporation of similar character under the laws of the state of Florida, including but not limited to the powers to make and enter contracts, receive and disburse funds granted by Federal, State, or private agencies or organization develop programs; conduct research; and coordinate, supervise, and Ad-

Article IX

Distribution of Assets upon Dissolution

Upon dissolution of G'S Athletic Testing Facility., INC all of its remaining assets after payment of all cost and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under 501 section (c) (3) of the Internal Revenue Code or to the Federal Government or to the State or Local government for a public purpose and none of the assets shall be distributed to any member, director, officer or trustee of this organization.




