- ONE: The name and address of this principal corporation is Riviera Community Development Outreach Program, Inc. 1417 10th St. W. Riviera Beach, FL 33407. The Corporation is organized pursuant to the FLORIDA Non-Profit Corporation Code.
- TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation organized under the Non-profit Public Benefit Corporation Law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Seminars, Worship Service, Outreach Advocacy Program for The Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

deductible under Section 170(c)(2) of the Internal Revenue Code.
