We, the undersigned, hereby associate ourselves together for the purpose of becoming a not for profit corporation pursuant to chapter 617, Florida Statutes, providing for the formation, liability, priviliges, rights and immunities of a not for profit corporation, hereby adopts the following Articles of Incorporation:
