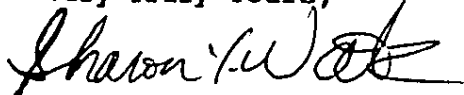

**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of this Corporation is Iglesia Evangelica Metodista de Marion Oaks, Inc.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purposes for which the corporation is organized are exclusively for charitable, religious, and educational purposes with in the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law). Without limiting the foregoing, the express purpose of this corporation is to preach, spread and promote the Gospel of Jesus of Nazareth by proclaiming the Word of God, the Holy Bible, both Old Testament and New Testament in every means known to, or to be made known to man for eternal healing, deliverance and prosperity of all who will believe in Jesus of Nazareth.

**ARTICLE IV - QUALIFICATION OF MEMBERS**

The authorized number and qualification of members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting and other rights and privileges of members and their liability for dues and assessments and the method of collection thereof, shall be set forth in the by-laws.

**ARTICLE VII - BY-LAWS**

Subject to the limitations contained in the by-laws and any limitations set forth in Chapter 617, Florida Statutes, concerning

corporate action that must be authorized or approved by the Membership of the Corporation, the by-laws of this Corporation may be made, altered, rescinded, added to, or new by-laws may be adopted, either by a resolution of the Board of Directors or by a procedure set forth in the by-laws of the Corporation.

#### **ARTICLE VIII - AMENDMENTS**

These Articles of Incorporation may be amended in the manner provided by Chapter 617 Florida Statutes, or as subsequently amended.

#### **ARTICLE IX - LOCATION**

The street address of the Corporation's initial/<sup>Principal</sup>registered office shall be:

#### **ARTICLE X - NON-PROFIT SHARE**

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation

for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. This Corporation shall be authorized to exercise the powers permitted non-profit corporations under Chapter 617 of the Florida Statutes; provided, however, that this Corporation in exercising any one or more of such powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE XI - DISTRIBUTION OF ASSETS UPON DISSOLUTION**

Upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or local Government, for a public purpose, and none of the assets will be distributed to any member, officer, or trustee of this organization. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the Fifth Judicial Circuit of Florida, in and for Marion County, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

the laws of the State of Florida.

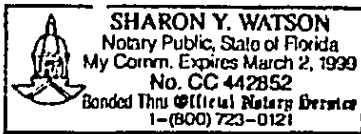

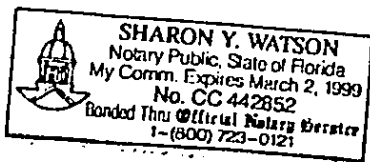

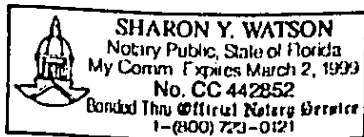
