The undersigned, for the purpose of forming a corporation for Non-Profit under the laws of Florida, adopts the following Articles of Incorporation:

ARTICLE I

Name and Business Address

Section 1.1 Name The name of the corporation is Blessed Ventures Child Care, Inc. The business address of the corporation is 2987 Downing St., Jacksonville, FL 32205.

ARTICLE II

Section 2.1. Duration. This corporation shall exist perpetually. Corporate existence shall be effective January 1, 1997.

ARTICLE III

Purposes

Section 3.1. Purposes. This Corporation is organized for the purpose of transaction any or all lawful business permitted under the Laws of the United States and of the State of Florida. Specifically for pre school child care.

ARTICLE IV

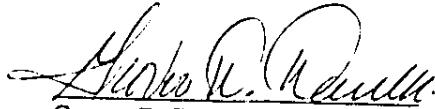
