ARTICLES OF INCORPORATION
OF THE

We, the undersigned persons of the State of Florida, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under Chapter 617, Laws of Florida 1959, as amended, and to hereby adopt the following Articles of Incorporation as our Charter:

Article I

The name of the corporation shall be Truevine Temple Ministries, Inc., with its principal place of business located at 855 Cypress Street Daytona Beach, in Volusia County, Florida.

Article II

The purpose for which this corporation is organized is to provide a general organization for Truevine Temple Ministries, Inc. in the United States and its Territories for the promotion of Church Missions at home and abroad and any other objectives such as Christian education, benevolent enterprises and social services which it may deem proper and advisable for furtherance of the Kingdom of God.

Article III

The members of this corporation shall be delegates who are members of Truevine Temple Ministries, Inc. in friendly cooperation with this corporation and sympathetic with its purposes and work. Every church shall be entitled to three delegates and one additional delegate to every hundred members in excess of one hundred, and any and all delegates certified to the corporation by the church sending same, but no church may appoint more than ten.

Article IV

This corporation shall exist perpetually or until dissolved by due process of law.

Article V

The name and residence of the original incorporator and subscriber to these Articles is as follows:

Article VI

The affairs of this corporation are to be managed by the following officers: President, Secretary and Treasurer and a Board of Trustees consisting of three or more members, and such other officers as may be provided for in the by-laws of this corporation. The President and Secretary shall also be the Chairman and Secretary, respectively, of the Board of Trustees. The officers and trustees of this corporation shall be elected by the members of this corporation as provided in the by-laws to serve for a period of one year or until their successors are elected and qualified, and the terms of the officers shall begin immediately at the close of the annual meeting. Upon the resignation, removal, or death of any officer or trustee of this corporation, the vacancy may be filled by the members of this corporation at any regular meeting of the corporation or at a special meeting called for that purpose.

Article VII

The first annual meeting of this corporation shall be held at such time and place as the President of the corporation may elect and call, and thereafter, the annual meeting of the corporation shall be held at such time and place as the members of the corporation may elect by a majority vote. The President, with the concurrence of the other officers and trustees of the corporation, when deemed expedient, may call special meetings of the members of the corporation and change the meeting place and the time of the annual meeting of the corporation.

Article VIII

A majority of the members of the corporation present at any meeting of the corporation shall be necessary for the election of the officers and trustees and to take action upon, adopt, or approve any matters of business.

Article IX

The names of the officers that are to serve until the first election under these Articles of Incorporation are as follows: President - T.L. Jackson, Secretary - Minnie Jordan, Treasurer - Louise Webb.

Article X

The names and addresses of the persons who are to serve as Trustees of this corporation until the first election thereof are as follows:

Article XI

These Articles of Incorporation may be amended when such amendment is proposed and adopted by a resolution by the members of the corporation at any business meeting of the corporation and shall become effective when such resolution is duly certified by the Secretary of the corporation and filed with the Secretary of State of the State of Florida, approved by him, and all filing fees have been paid.

Article XII

This corporation shall have power from time to time to make such contracts and do such things as shall be authorized by the members of this corporation and the laws of the State of Florida. All legal contracts of the corporation shall be signed by the President and attested by the Secretary.

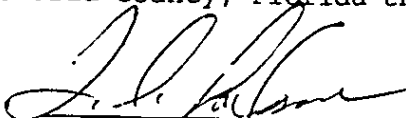
ARTICLE XIII

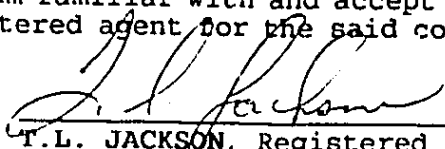

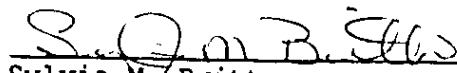

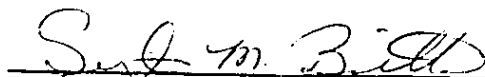
