ARTICLE 1. NAME.

- E. To cooperate with federal governments, their agencies and other organized groups for the benefit of the public at large and for the specific benefit of the people of Cuba whether at home or abroad.
- F. To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations/societies.
- G. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall insure to the benefit of or be distributed to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and make payment and distributions in furtherance of its stated purpose.

## ARTICLE 6. APPOINTMENT OF DIRECTORS.

The method of appointment and election of directors shall be strated in the bylaws of the corporation.
