ARTICLES OF INCORPORATION

ARTICLE 1. NAME.

The name of the corporation shall be: We Free Cuba, Inc.

ARTICLE 2. ADDRESS.

The principal place of business of the corporation shall be:

ARTICLE 3. EFFECTIVE DATE

The effective date for the forming of the Corporation shall be January 1, 1997.

ARTICLE 4. DURATION.

The duration of the corporation is perpetual.

ARTICLE 5. PURPOSE.

The specific purposes for which the corporation is organized are:

A. To carry on legal activities designed to address and publicize the human rights and humanitarian issues within the country of Cuba.

B. To promote a broader understanding of the political system of the country of Cuba.

C. To provide a forum for the advancement and exchange of information and ideas related, but not limited to, the system of political administration in the country of Cuba.

D. To stimulate and encourage the establishment and maintenance of a democratic system of government in the country of Cuba.

E. To cooperate with federal governments, their agencies and other organized groups for the benefit of the public at large and for the specific benefit of the people of Cuba whether at home or abroad.

F. To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations/societies.

G. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and make payment and distributions in furtherance of its stated purpose.

ARTICLE 6. APPOINTMENT OF DIRECTORS.

The method of appointment and election of directors shall be stated in the bylaws of the corporation.

ARTICLE 7. CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302 Florida Statutes.

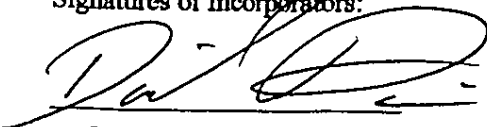
