The undersigned does hereby, make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a non-profit corporation pursuant to the Florida Not for Profit Corporation Act.

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation shall be KIDS IN JAMAICA, INC.

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**
