The undersigned incorporator, desiring to form a corporation not for profit under the provisions of Florida Statutes Chapter 617, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Name and Principal Address

The name of this corporation shall be YOUTH SOFTBALL ASSOCIATION OF APOPKA, INC. and its principal address shall be 11 Oak Hammock Lane, Apopka, Florida 32712.

ARTICLE II

Term and Commencement

This corporation shall have perpetual existence unless dissolved according to law. Corporate existence shall commence with the filing of these Articles of Incorporation.

ARTICLE III

Purposes

The corporation has not been organized for pecuniary profit. The purposes for which the corporation is organized are:

- A. To perform any and all functions with regard to the running and organization of a softball league.
- B. To have and to exercise all powers conferred on a corporation organized under the Florida Not for Profit Corporation Act as currently in effect and as it may be amended, including without limitation all powers necessary or convenient to effect the purposes for which the corporation is organized.

ARTICLE IV

Members

The qualifications for members and the manner of their admission shall be as regulated by the bylaws.

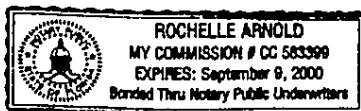

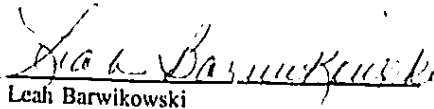

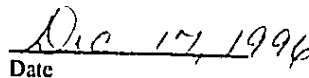
