**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF THE RIDGES MAINTENANCE ASSOCIATION, INC.**

THESE ARTICLES OF AMENDMENT are adopted as of the date shown below

1. Name: The name of the corporation is The Ridges Maintenance Association, Inc., a Florida corporation not for profit.

2. Article III, Section 2 of the Articles of Incorporation is hereby amended by deleting all references to Neighborhood Committees such that Voting Members shall be elected directly by the Members in each Neighborhood.

3. Article V, Section 1 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:


Section 1. Management by Directors. The property, business and affairs of the Association shall be managed and conducted by a Board of Directors consisting of seven (7) persons elected by the Voting Members in accordance with these Articles and the By - Laws.

4. Approval of Amendment: Arvida/JMB Partners, a Florida general partnership, is the "Developer" under the Articles of Incorporation and, pursuant to Article VIII, Section 1 thereof and has the authority to unilaterally amend the Articles without a vote of the Members. Accordingly, these Articles of Amendment have been executed by John Baric, the Vice President of the Developer in order to evidence such approval.

IN WITNESS WHEREOF, these Articles of Amendment have been executed and adopted as of October 12, 1999.
