

AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE RIDGES MAINTENANCE ASSOCIATION, INC.

THE UNDERSIGNED, being the "Association" under and as defined in the Articles of Incorporation of The Ridges Maintenance Association, Inc., a Florida Corporation Not for Profit, which Articles of Incorporation constitute Exhibit "A" to the Declaration of Covenants for The Ridges Maintenance Association, Inc., recorded in Official Records Book 24095, Page 120, of the Public Records of Broward County, Florida, hereby amends the Articles of Incorporation in accordance with Article VIII, Section 1 thereof, as follows:

1. Article V, Section 6 is hereby amended by deleting the existing Section in its entirety and replacing it with the following:

<u>Section 6.</u> Term of Office. In accordance with the By-Laws, Directors elected by Class A Voting Members shall serve staggered two-year terms (but may succeed themselves).

2. Article VIII is hereby amended by deleting the existing Section 1 in its entirety and replacing it with the following:

Section 1. These Articles of Incorporation may be amended by a majority of the Board of Directors of the Association or by 75% of the votes of the total votes of the Voting Members, and approved in the manner provided in the Florida Statutes.
