The name of the corporation is FRIENDS OF THE SUNTREE-VIERA LIBRARY, INC., hereinafter called the "Friends."

ARTICLE II - PRINCIPAL OFFICE

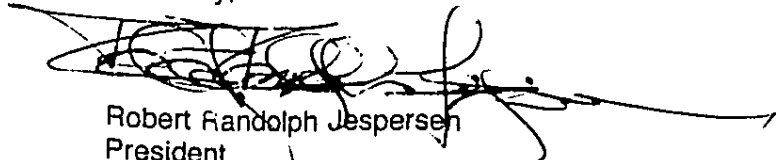

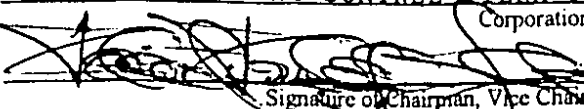

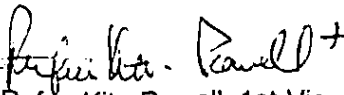
NOW, THEREFORE, BE IT RESOLVED THAT:
