AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

FRIENDS OF THE SUNTREE-VIERA PUBLIC LIBRARY, INC.

ARTICLE I - NAME

The name of the incorporation is FRIENDS OF THE SUNTREE-VIERA PUBLIC LIBRARY, INC., hereinafter called the "Friends."

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office is 7200 Wickham Road, Melbourne, Florida 32940, which is the same mailing address of the Friends.

ARTICLE III - REGISTERED AGENT

The street address of the corporation's registered office and the name of the registered agent is Father Rufus B. Kite-Powell, 7200 Wickham Road, Melbourne, Florida 32940.

ARTICLE IV - PURPOSE OF THE FRIENDS

Friends does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are:

- 1. To foster and promote a positive image of the Suntree-Viera Public Library with its local citizens.
- 2. To sponsor, conduct or to participate in fund raising projects to benefit Suntree-Viera Public Library, and to encourage gifts and memorials of funds, books, art objects, and others.
- 3. To sponsor, conduct, or participate in approved cultural or community service activities related to library goals and purposes.
- 4. To operate within the meaning of section 501(C)3 of the Internal Revenue Code of 1986 as amended and shall otherwise comply with any requirements for classification as an exempt organization under such section.



- 5. To assist and support the Library Services Director and Library Board in extending and improving library services and resources.
- 6. To provide services and resources not otherwise available to Suntree-Viera Public Library and its staff.

ARTICLE V - ELECTION OF DIRECTORS

ARTICLE X - COMMITTEES

Rules governing committees shall be stated in the bylaws.

ARTICLE XI - DUES AND FINANCES

The methods concerning dues and finances shall be stated in the bylaws.

ARTICLE XII - NET EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE XIII - DISSOLUTION

Upon dissolution of this of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.
