

METHODS BY WHICH MEMBERSHIP MAY BE GRANTED:

- A: BY PROFESSION OF FAITH IN CHRIST AND BAPTISM.
- B: BY LETTER FROM A CHURCH OF LIKE FAITH AND ORDER.
- C: BY RESTORATION. ANY PERSON WHOSE MEMBERSHIP HAS BEEN TERMINATED FOR ANY OFFENSE MAY BE RESTORED BY VOTE OF THE CHURCH, UPON EVIDENCE OF HIS REPENTANCE AND REFORMATION; OR, IF AN ACCOUNT OF CONTINUED ABSENCE, UPON SATISFACTORY EXPLANATION.
- D: BY STATEMENT, PROVIDED HIS CHURCH IS NOW NONEXISTENT, OR RECORDS LOST, OR WHEN SATISFACTORY EXPLANATION IS GIVEN FOR NOT BEING ABLE TO SECURE A LETTER.

RIGHTS:

- A: SUCH MEMBERS AS ARE IN FULL AND REGULAR STANDING MAY ACT AND VOTE IN BUSINESS TRANSACTIONS OF THE CHURCH.
- B: VOTING AGE BEING DETERMINED AS AT LEAST 16 YEARS OF AGE, AND IN FULL ACTIVE STATUS IDENTIFIED BY AT LEAST 50% ATTENDANCE SINCE MEMBERSHIP.

METHODS BY WHICH MEMBERSHIP MAY BE TERMINATED:

- A: BY LETTER OF DISMISSAL TO A CHURCH OF LIKE FAITH AND ORDER. LETTERS SHALL NOT BE GRANTED DIRECTLY TO THE INDIVIDUAL, EXCEPT IN EXTREME CASES WHERE SUCH IS DEEMED WISE.
- B: BY DROPPING FROM THE ROLL, WHEN PERSONS JOIN ORDERS OF OTHER FAITH.
- C: BY EXCLUSION,
 - 1) THE CHURCH MAY, AFTER DUE NOTICE AND HEARING AND KINDLY EFFORT TO MAKE SUCH ACTION UNNECESSARY, TERMINATE THE MEMBERSHIP OF PERSONS WHO ARE NONRESIDENT FOR THE SPACE OF ONE YEAR, OR WHO, FOR THE SAME PERIOD OF TIME DO NOT WORSHIP WITH THE CHURCH.
 - 2) SHOULD A MEMBER BECOME AN OFFENSE TO THE CHURCH AND TO ITS GOOD NAME BY REASON OF IMMORAL OR UNCHRISTIAN CONDUCT, OR BY PERSISTENT BREACH OF HIS (OR HER) COVENANT VOWS, THE CHURCH MAY TERMINATE MEMBERSHIP, BUT ONLY AFTER DUE NOTICE AND HEARING, AND AFTER FAITHFUL EFFORTS HAVE BEEN MADE TO BRING SUCH MEMBER TO REPENTANCE AND AMENDMENT.

MEMBERSHIP IS NONTRANSFERABLE.


