ARTICLES OF INCORPORATION
OF
MUSLIM BUSINESS & PROFESSIONAL ASSOCIATION, INC.,

The undersigned subscribers to these Articles of Incorporation, each a natural personal competent to contract, hereby associate themselves to form a nonprofit corporation under the Laws of the State of Florida.

Article I

The name of this nonprofit corporation shall be Muslim Business & Professional Association.

Article II

The duration of this nonprofit corporation shall be perpetual unless dissolved in accordance with the Laws of the State of Florida.

Article III

This nonprofit corporation is organized for educational, scientific, social, cultural and charitable purposes for which a corporation not for profit may be incorporated under the laws of the United States of America and the State of Florida.

Article IV

This nonprofit corporation is organized upon a non-stock basis and shall not issue shares of stock.

Article V

Membership of this nonprofit corporation may be evidenced by a certificate of membership which shall contain the statement, printed prominently upon the face of the certificate, that the corporation is a nonprofit corporation. The qualifications for members and the manner of their admission are to be regulated by the corporation's bylaws. The manner in which directors are elected or appointed shall also be regulated by the corporation's bylaws.

Article VI

Article VII


This nonprofit corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.


