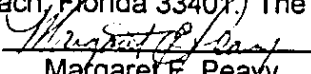

ONE: The name and address of this principal corporation is SUNSHINE LEISURE CARE, INC., 1352 6th Street, West Palm Beach, Florida, 33401. The corporation is organized pursuant to the Fulton County Nonprofit Corporation Code.

TWO: This corporation is a nonprofit mutual benefit corporation and is not organized for the private gain of any person. The corporation organized under the Nonprofit Mutual Benefit Corporation Law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Seminars, Worship Service, Childcare, Counselling, Outreach Advocacy Programs For The Youth At High Risk, Health Care, Homeless, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aide those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

FIVE: This corporation is organized and operated exclusively for
(a) Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

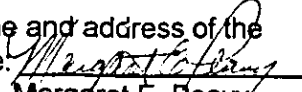
SIX: The directors are elected in accordance with the Bylaws. The name and address of the person appointed to act as the initial directors of this corporation are:

SEVEN: The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Charitable and Educational under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
