The undersigned, acting as the incorporators, do hereby desire to form a corporation not for profit pursuant to the Florida Not For Profit Corporation Act and do hereby adopt the following Articles of Incorporation:

Article I- Name of Corporation

The name of the corporation shall be DAYSTAR, INC.

Article II- Principle Office;  
Mailing Address

The location and mailing address of the principal office of the corporation shall be 2657 Breezwind Drive, Orlando, Florida 32839. The location of the principal office shall be subject to change as may be provided in the Bylaws duly adopted by the members of the corporation.

The corporation shall commence its corporate existence upon the execution of these Articles of Incorporation and shall exist perpetually.

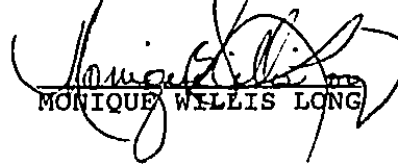
Article VIII- Indemnification

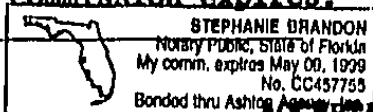
