Pursuant to the requirements of Florida Statute 617.1403, the following Articles of Dissolution of HFA VENTURES, INC., a Florida not-for-profit corporation, were duly adopted by the Corporation as follows:

1. The name of the Corporation is HFA VENTURES, INC., a Florida not-for-profit corporation.
2. The Charter Number for the Corporation is N96000006614.
3. A resolution to dissolve the Corporation was adopted by written consent of a majority of the members of the Board of Trustees on October 24, 2002 and executed in accordance with Florida Statute 617.0701. The number of votes cast for dissolution was sufficient for approval.
4. The Corporation has no members with voting rights. The number of Trustees in office is three (3) and the vote for the resolution was unanimous by all Trustees.
5. The effective date of these Articles of Dissolution shall be as of the date of filing with the Secretary of State.
