*Pursuant to the provisions of section 617.1006, Florida statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST: Amendments adopted:**

**Article One:** The new name and principal address of the Corporation shall be There's Hope, Incorporated, 6871 N. W. 26th Court, Sunrise, FL 33313, Broward County. The organization is organized pursuant to FLORIDA Nonprofit Corporation Code.

**Article Two:** This Corporation is a Nonprofit Public Benefit Corporation and is not organized for the private of any person. This Corporation is organized under the Non-profit Public Benefit Law for religious, charitable and educational purposes, to aid the the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of, but shall not be limited to: Counseling, Job Training and Placement, Land Acquisition and Housing, Emergency and Temporary Shelter, Employment Assistance Services, Literacy awareness and prevention, Education Advancement via tutoring, counseling and mentoring of Youth at Risk, Teenage Pregnancy and Prevention, Substance Abuse awareness and prevention, Health and Hygiene awareness, Food and Nutrition awareness, Food Bank, Elderly Care and other programs to aid those in need.

**Article Four:** The address of the REGISTERED office is 6871 N.W. 26th Court, Sunrise, FL 33313, Broward County, and the name of the registered agent is the same.


**Article Six:** The Directors are elected in accordance with the Bylaws. The names and addresses of the persons appointed to act as Directors of this corporation are:
