**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION OF
FLORIDA BREAST CANCER RESOURCE NETWORK CORPORATION**

Pursuant to the provision of Section 617.1006 of the Florida Business Corporation Act, the undersigned non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is FLORIDA BREAST CANCER RESOURCE NETWORK CORPORATION (the "Corporation").

2. The following amendment of the Articles of Incorporation was agreed to and adopted by the directors of the Corporation on the 1st day of March, 1998, in the manner prescribed by Section 617.1002 of the Florida Not-For-Profit Corporation Act: There are no members.

ARTICLE TEN of the Articles of Incorporation of the Corporation shall be amended by adding the following paragraph:

"In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are then exempt as organizations described in Section 501(c)(3) and 170(c)(3) of the Internal Revenue Code of 1986, or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or Local government for exclusive public purposes."
