**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION**

Pursuant to and in compliance with the requirements of Section 617.1006, Florida Statutes, Hemophilia of the Sunshine State, Inc., a not-for-profit corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby adopts the following amendments to the Corporation's Articles of Incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation is amended and read as follows:

**ARTICLE I
NAME**

The name of the Corporation is: **HEMSUN LIQUIDATION COMPANY.**

SECOND: Article IV of the Corporation's Articles of Incorporation is amended to read as follows:

**ARTICLE IV
MEMBERS**

SWI Liquidation Company, formerly known as Sunshine Wholesale, Inc., a Florida corporation, shall be the sole member of the Corporation. The Member shall have the right to designate the members of the Board of Directors of the Corporation in the manner set forth in the Bylaws of the Corporation.

THIRD: Each of the foregoing amendments to the Corporation's Articles of Incorporation was approved by the Board of Directors of the Corporation on May 13, 2002, and the number of votes cast for each amendment was sufficient for the approval of said amendment. The Corporation does not have members entitled to vote of the amendments set forth above.

FOURTH: These Articles of Amendment to the Corporation's Articles of Incorporation shall become effective immediately upon their filing by the Secretary of State of Florida.
