**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF DANSVILLE NEIGHBORHOOD DEVELOPMENT CORPORATION**

1. Pursuant to Section 617.1002 of the Florida Statutes, the Articles of Incorporation of DANSVILLE NEIGHBORHOOD DEVELOPMENT CORPORATION (the "Corporation") are hereby amended as follows:

- (a) Article X is hereby deleted, and the following is inserted in its stead:

"Article X-Dissolution"

Upon a dissolution of the Corporation, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or to the federal, state or local government for exclusive public purpose."

- (b) There is hereby added a new Article XI to the Articles of Incorporation as follows:

"Article XI-Certain Actions"

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding sections of any future Federal tax code)."

2. As hereby amended, the Articles of Incorporation of the Corporation are hereby ratified and affirmed.

3. There are members of the Corporation entitled to vote on the foregoing Articles of Amendment (the "Amendment"). The Amendment was adopted by the members on 7/10, 2000. The number of votes cast for the Amendment was sufficient for approval.


