ARTICLES OF INCORPORATION HERITAGE OAKS GOLF VILLAS ASSOCIATION, INC.

ARTICLE I

NAME: The name of the corporation is Heritage Oaks Golf Villas I Association, Inc., sometimes hereinafter referred to as the "Association."

ARTICLE III

PURPOSE AND POWERS: This Association will not permit pecuniary gain or profit and will make no distribution of its income to its members, officers or Directors. It is a Florida corporation not for profit organized on a non-stock basis, for the purpose of acting as a corporate residential neighborhood homeowners' association pursuant to Chapter 720. Florida Statutes for the operation and management of HERITAGE OAKS GOLF VILLAS I, the Declaration of Covenants, Conditions and Restrictions of which is recorded at Official Records Book 3020. Page 1399 et seq: HERITAGE OAKS GOLF VILLAS II, the Declaration of Covenants. Conditions and Restrictions of which is recorded at Official Records Instrument Number 1998082052 et seg.; HERITAGE OAKS GOLF VILLAS III, the Declaration of Covenants, Conditions and Restrictions of which is recorded at Official Records Instrument Number 1999066352 et seq.; HERITAGE OAKS GOLF VILLAS IV. the Declaration of Covenants. Conditions and Restrictions of which is recorded at Official Records Instrument Number 2000018336 et seg.; HERITAGE OAKS GOLF VILLAS V, the Declaration of Covenants. Conditions and Restrictions of which is recorded at Official Records Instrument Number 2000118066 et seq.; and HERITAGE OAKS GOLF VILLAS VI, the Declaration of Covenants, Conditions and Restrictions of which is recorded at Official Records Instrument Number 2001028128 et seg., all of, and it will, subject to a Declarations of Covenants, Conditions and Restrictions, recorded, or to be recorded in the Public Records of Sarasota County, Florida, (herein referred to as "the Declarations"). The Association shall have the powers stated in the Declarations and in with these Articles attached as Exhibit "B," have the powers described herein.

The Association shall have all of the common law and statutory powers of a Florida corporation not for profit consistent with these Articles and with the Declarations of Covenants, Conditions and Restrictions; and it shall have all of the powers and authority reasonably necessary or appropriate to the operation and regulation of a residential neighborhood, subject to the Declarations, as it they may from time to time be amended, including but not limited to the power to:
