Articles of Merger of Ashley Oaks Unit 3 Homeowners' Association, Inc. And Ashley Oaks Homeowners Association, Inc.

I. Plan of Merger

This plan of merger is adopted pursuant to the provisions of Section 617.1101, Florida Statutes (1995), between Ashley Oaks Homeowners Association, Inc., a Florida corporation, and Ashley Oaks Unit 3 Homeowners' Association, Inc., a Florida corporation.

- 1. The names of the corporations proposing to merge are Ashley Oaks Homeowners Association, Inc., and Ashley Oaks Unit 3 Homeowners' Association, Inc. The name of the surviving corporation shall be Ashley Oaks Unit 3 Homeowners Association, Inc. which shall hereby change its name to Ashley Oaks Master Association, Inc.
 - The terms and conditions of consolidation are as follows:
 - a. The merger shall become effective upon filing of articles of merger from both corporations with the Department of State. Thereafter, Ashley Oaks Homeowners Association, Inc. shall cease to exist and be merged into the surviving corporation.
 - b. The officers of Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be Gary Chapman as President; Robert Moody as Vice President and Leonard Terry Stanton as Secretary/Treasurer.
 - c. The Board of Directors of Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be Gary Chapman, Terry Stanton, Robert Moody, and Ann McCabe.
 - d. The Articles of Incorporation of Ashley Oaks Unit 3 Homeowners' Association, Inc., shall become the Articles of Incorporation of Ashley Oaks Unit 3 Homeowners' Association, Inc.
 - e. Ashley Oaks Unit 3 Homeowners' Association, Inc., shall have all of the rights, privileges, immunities and franchises of Ashley Oaks Homeowners Association, Inc., and Ashley Oaks Unit 3 Homeowners' Association, Inc.; and all property of whatsoever kind, whether real, personal, intangible or mixed, and all debts due on any account, and all chosen in action, and each and every interest belonging to Ashley Oaks Homeowners Association, Inc., and Ashley Oaks Unit 3 Homeowners' Association, Inc., without further act or deed.
 - f. Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be responsible and liable for all liabilities and obligations of Ashley Oaks Homeowners Association, Inc., and Ashley Oaks Unit 3 Homeowners' Association, Inc., and any existing claim or action or proceeding pending against either may be prosecuted as if no consolidation had been effected.
 - g. All Class "A" members of the Ashley Oaks Homeowners Association, Inc., and of the

Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be Class "A" members of the Ashley Oaks Unit 3 Homeowners' Association, Inc. The Class "B" member of the Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be the Class "B" member of the Ashley Oaks Master Association, Inc. Article V, Section 2 of the Declaration of Covenants, Conditions and Restrictions of Ashley Oaks Unit 3, recorded at O.R. Book 8523, page 0953 of the Public Records of Hillsborough County which states:

"The Class B member shall cast its votes with the majority of Class A votes, in all issues except financial matters such as but not limited to the following:

a. Adoption of the budget, adoption of special assessments or other financial matters."

is specifically incorporated into the Articles of Merger.

- h. The registered agent of the Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be Gary Chapman, whose address is 306 E. Jackson St., Suite 7E, Tampa, Florida 33602.
- i. Ashley Oaks Unit 3 Homeowners' Association, Inc., shall assume all duties and responsibilities of Ashley Oaks Homeowners Association, Inc., under the Declaration of Covenants, Conditions and Restrictions recorded at O.R. 4863, Page 223 of the Public Records of Hillsborough County, Florida, as amended, as said Declaration applies to Ashley Oaks Phase 1 as recorded at Plat Book 60, Page 24 of the Public Records of Hillsborough County, Florida, and Ashley Oaks Phase II as recorded at Plat Book 66, Page 17 of the Public Records of Hillsborough County, Florida.
- j. Ashley Oaks Unit 3 Homeowners' Association, Inc., shall assume all duties and responsibilities of Ashley Oaks Unit 3 Homeowners' Association, Inc., under the Declaration of Covenants, Conditions and Restrictions for Ashley Oaks Unit 3 Homeowners' Association, Inc., recorded at O.R. 8523, Page 0953 of the public records of Hillsborough County, Florida, as amended.
- k. The Bylaws of the Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be the existing Bylaws of the Ashley Oaks Homeowners Association, Inc.
- 1. All committees of the Ashley Oaks Homeowners Association, Inc., including the Architectural Review Committee, shall be existing committees of the Ashley Oaks Unit 3 Homeowners' Association, Inc. Approval by the Architectural Control Committee shall not be required and shall not apply to new construction by Ashley Oaks Partners or a home builder performed prior to the issuance of a Certificate of Occupancy.
- m. The rules and regulations of the Ashley Oaks Homeowners Association, Inc., shall become the existing rules and regulations of the Ashley Oaks Unit 3 Homeowners' Association, Inc.
- 3. The Articles of Incorporation of the surviving corporation, Ashley Oaks Unit 3 Homeowners' Association, Inc., shall be changed from the Articles of Incorporation of Ashley Oaks 122396.ashleyoak.mer

Onit 3 Homeowners' Association, Inc., only in that the name of the corporation shall be Ashley Oaks Master Association, Inc.

- 4.a. All property in Ashley Oaks Unit 3 shall remain subject to the Declaration of Covenants, Conditions and Restrictions of Ashley Oaks Unit 3 as recorded at O.R. Book 8523, Page 0953 of the public records of Hillsborough County.
- b. All property in Ashley Oaks Phase I and Ashley Oaks Phase II shall remain subject to the Declaration of Covenants, Conditions and Restrictions as recorded at O.R. 4863, Page 0223 of the public records of Hillsborough County.

II. Approval of Members

- A. The Plan of Merger was adopted by the members of Ashley Oaks Homeowners Association, Inc., by written consent, without a meeting, and executed in accordance with Section 617.0701, Florida Statutes (1995), by a majority of the members of the Association, which is a number sufficient for approval. The vote on the Plan of Merger was 90 members in favor, 0 opposed, and 20 not returning votes. On December 29, 1997.
- B. The Plan of Merger was adopted by the members of Ashley Oaks Unit 3 Homeowners' Association, Inc., by written consent, without a meeting, and executed in accordance with Section 617.0701, Florida Statutes (1995), by a majority of the members of the Association, which is a number sufficient for approval. The vote on the Plan of Merger was 11 members in favor, opposed, and 5 not returning votes on December 29, 1997.
- III. The effective date of this merger shall be upon delivery of these Articles of Merger to the Department of State. I hereby accept to act as registered agent and agree to comply with the provision of said Act relative to keeping open said office on December 29, 1997.
