ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
THREE RESOURCE MINISTRY, INC.

The undersigned, President of THREE RESOURCE MINISTRY, INC., a Florida not-for-profit corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 617.1006 of the Florida Not-for-Profit Corporation Act (the "Act"), states as follows:

1. The name of the Corporation is THREE RESOURCE MINISTRY, INC.
2. The Articles of Incorporation of the Corporation are amended by deleting Article I in its entirety and replacing it with the following:

"ARTICLE I. - Name

The name of the Corporation is Global Youth Ministry, Inc.

3. The Amendment to the Articles of Incorporation of the Corporation (the "Amendment") was approved by a majority of the Board of Directors of the Corporation at a meeting on August 16, 2004.

4. The Corporation does not have any members.
