TO

ARTICLES OF INCORPORATION

OF

CHRISTIAN FAITH OUTREACH COMMUNITY DEVELOPMENT CORPORATION, INC. DOCUMENT NUMBER N9700000881

Pursuant totthe provision of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE III ADDED

The purpose of the corporation shall be exclusively educational, charitable, and scientific, within the meaning of section 501(c)(3) of the United States Internal Revenue Code, or the corresponding provision of the future United States Internal Revenue Law. No substaintial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legistaton, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this, this organization shall not carry on any other activities not premitted not to be carried on by an organization exempt from the federal income tax under section 501(c)(3) of the present Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and make payments and distributions in furtherance of Section 501(c)(3) purpose.

This corporation shall have the right to promote spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed. To operate a afterschool care, alcohol/drug counseling, clothing closet, day care, Food pantry, HIV/AIDS ministry, homeless ministries, jail ministry, mom's day out; multi-housing ministry, parenting classes, summer camp, refugee resettlement and tutoring children & youth.
