CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE VILLAGES AT BUCKINGHAM, INC.

DIVISION OF CHARGE STATIONS

WE HEREBY CERTIFY THAT, the amendment to the Articles of Incorporation set out herein and made a part hereof (said Articles being recorded in Official Records Book 2828, at Page 1027, et. als., of the Public Records of Lee County, Florida) passed in accordance with the necessary affirmative votes of the membership to pass the amendments as required by Article VII of the Articles of Incorporation; and that as a result of the foregoing, and proper notice having been given, said amendments have been duly adopted, on February 20, 1998.

(Underlined language is added and cross through language is deleted).

ARTICLE III, SUBSECTION (I) shall be amended as follows:

(I) To borrow or raise money for any purposes of the Community Association; to draw, make, accept, endorse execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures and other negotiable for non-negotiable instruments and evidences of indebtedness; and to secure the payment of any thereof, and of the interest therein, by mortgage pledge, conveyance or assignment in trust, of the whole or any part of the rights of property of the Community Association.

Mortgaging of any or all of the Association's real or personal property requires the approval of two-thirds (2/3rds) of each class of members.

ARTICLE VII, SUBSECTION (B) shall be amended as follows:

(B) <u>Vote Required</u>. Except as otherwise required by Florida law, a proposed amendment to these Articles of Incorporation shall be adopted if it is approved by <u>at least two-thirds (2/3rds) of the total voting interests a majority of the voting</u> at any annual or special meeting, provided that notice of any proposed amendment has been given to the Members of the Community Association, and that the notice contains the text of the proposed amendment.

ARTICLE VII, SUBSECTION (D) shall be added as follows:

(D) Prior Approval of HUD, FHA OR VA. There shall be no annexation of additional properties, dissolution of the Association and/or amendment of the Articles of Incorporation without prior approval of HUD, FHA or VA as long as the Declarant controls the Association and appoints the majority of the Board of Directors.

ARTICLE VII, SUBSECTION (E) shall be added as follows:

(E) Any merger, consolidation	or annexation of lands requires the approval or
