ARTICLES OF INCORPORATION OF

VA Research Foundation of the Palm Beaches, Inc.

(Restated)

The undersigned, acting as officers of the corporation pursuant to chapter 617, Florida Statues, adopt the following restated Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of the Corporation is: VA Research Foundation of the Palm Beaches, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

VA Research Foundation of the Palm Beaches, Inc. 7305 North Military Trail (151)
West Palm Beach, Fl 33410-6400

ARTICLE III PURPOSES

The corporation is a non-profit corporation and shall be operating exclusively for charitable, scientific and educational purposes within the meaning of, and in compliance with, Section 501 (c) (3) of the Internal Revenue code of 1986, as amended (the "Code"). Such purposes shall include:

- (a) To facilitate medical research, including investigations, experiments and studies to discover, develop or verify knowledge relating to the causes, diagnosis, treatment or control of physical or mental diseases and impairments of mankind, in conjunction with the Veterans Affairs Medical Center, at 7305 North Military Trail, West Palm Beach, Fl. 33410-6400; and
- (b) To make the results of such research available to the scientific and general public by means of research communications in recognized journals widely distributed to libraries and the medical community, and by means of scientific lectures and open meetings organized by the corporation; and

(c) To provide a flexible mechanism for the receipt and administration of research funds, not appropriated to the Department of Veterans Affairs, for the conduct of approved VA related research and educational activities.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

- (a) The Medical Center Director, Chief of Staff and Research Coordinator at the VA Medical Center located at 7305 North Military Trail, West Palm Beach, Fl 33410-6400 shall be permanent members of the Board of Directors in accordance with federal laws and regulations.
- (b) At least two persons who are not officers or employees of the Federal Government and who are familiar with the issues involving medical research shall be members of the Board of Directors. Their term of office shall be set by a quorum of the voting members of the Board of Directors and approved by the Medical Center Director.
- (c) The Board of Directors may, from time-to-time elect, by a quorum of the voting members, additional members to the Board of Directors. Their term of office shall be set by a quorum of the voting members of the Board of Directors and approved by the Medical Center Director.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporation shall retain all powers listed in Florida Statute 617.0302, without limitation

ARTICLE VI REGISTERED AGENT

The registered office shall be Regional Counsel, 10000 Bay Pines Blvd., Bay Pines, Fl 33744. The registered agent shall be Ms. Ruth Dowling, Esq.
