Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

Those certain Amended and Restated Articles of Incorporation of Westminster Retirement Communities, Inc., a Florida not-for-profit corporation (the "Corporation"), filed with the State of Florida on August 26, 1999 (the "Articles of Incorporation"), are amended as follows:
