**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF

TO THE SECRETARY OF STATE OF THE STATE OF FLORIDA:


The undersigned corporation, pursuant to the Florida Nonprofit Corporation Act, Chapter 617 of the Florida Code, adopts the following Articles of Incorporation for such corporation:

1. The name of the Corporation is Association for the Calligraphic Arts, Inc. and the Corporation was incorporated on March 11, 1997.
2. Article III of the Articles of Incorporation is amended and restated to read as follows:

This Corporation is organized exclusively as a business league within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, to promote the public awareness of and appreciation for the study and practice of calligraphy and lettering arts. As a means of accomplishing the foregoing purpose the Corporation shall have all the general powers set forth in Chapter 617 of the Code of Florida, as it may hereafter be amended from time-to-time. These general powers shall be exercised exclusively for the attainment of the purpose of the Corporation as set forth in this Article.


3. Article VI of the Articles of Incorporation is amended by deleting the last sentence thereof.
4. The date of adoption of this Amendment was April 10, 1998.
5. This Amendment was adopted by a vote of a majority of the Board of Directors of the Corporation. There are no members entitled to vote on this Amendment.
