ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE STARTING PLACE FOUNDATION, INC.



The undersigned, President and Secretary of THE STARTING PLACE FOUNDATION, INC., a Florida not-for-profit corporation, hereby certify that the following resolution was adopted by the unanimous written consent of all of the members and directors of the Corporation, by corporate action effective as of May 1997.

RESOLVED, that Article VIII of the Articles of Incorporation of THE STARTING PLACE FOUNDATION, INC., be amended to include the following sentence after what is presently stated:

"ARTICLE VIII DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes."

The date of adoption of this Amendment by the Members and Board of Directors is May 29° , 1997.
