ARTICLES OF AMENDMENT OF MAD DADS OF GREATER HENDRY COUNTY, INC.

FILED

TALLAHASSEE FLORIDA

March 11, 1997, the members and Directors of MAD DADS of Greater Hendry County, Inc., a Florida corporation not for profit, unanimously adopted the following amendment to the articles of Incorporation.

ARTICLE II, Section (4) is deleted in its entirety and the following is substituted therefor;

(4) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization and operated exclusively for such purposes.

ARTICLE III is amended to include the following;

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
