

Articles of Amendment to Articles of Incorporation of Brevard Ferret Lovers Rescue, Inc.



We, the undersigned, being the officers of Brevard Ferret Lovers Rescue, a Florida not-for-profit corporation, hereby certify that the following Amendments were unanimously adopted by the members and Directors of the corporation by unanimous written consent at a meeting held on the 6th day of December 1997.

1. ARTICLE II - Corporate Nature

Article II is hereby amended to read:

"The purposes for which Brevard Ferret Lovers Rescue, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."

2. ARTICLE IV - General and Specific Purposes

- A. Article IV(e) is hereby deleted in its entirety.
- B. Article IV(f) is hereby deleted in its entirety.

3. ARTICLE VI - Earnings and Activities of Corporation

Article VI(c) is hereby amended to read:

"Notwithstanding any other provision of the articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."

4. ARTICLE X - Amendment of Bylaws

Article X is hereby deleted in its entirety.

In all other respects, the articles of Incorporation shall remain as they were prior to this Amendment being adopted.
