Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(s) BEING AMENDED, ADDED REDETED

Article III. Purpose, amended to read as follows:

- 1. The purpose for which Good Hope Baptist Church Inc. is organized are exclusively religious, charitable, scientific, literary and educational within meaning of section 501(C) (3) of the pregnal revenue Code of 1986 or the corresponding provision of any future United States Internal law.
- 2. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt form Federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986, or corresponding provision of any future United States Internal Revenue law.
- 3. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for public purpose. Any such assets not so disposed of shall be disposed of by court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
