ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LITTLE CHILDREN OF FUNDANA, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

RESOLVED, that the following Articles of Incorporation of Little Children of Fundana, Inc. shall be amended in its entirety as follows:

ARTICLE I - NAME

The name of this Corporation shall be AMERICAN FRIENDS OF LITTLE CHILDREN, INC.

ARTICLE VII - BOARD OF DIRECTORS

Except as otherwise provided by law, by these Articles of Incorporation, or by the Corporation Bylaws, the business and affairs of this Corporation shall be conducted by, and the powers of this Corporation shall be exercised by or under the authority of a Board of Directors.

The Board of Directors shall be elected or appointed as set forth in the Bylaws. This Corporation shall have four (4) directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one. The Directors named herein as the initial Directors shall hold office until the first organizational meeting of the Board of Directors of the Corporation, at which time a new Board of Directors shall be elected or appointed as provided for in the Corporation Bylaws. ARTICLE XI - PRIVATE PROPERTY

The private property of the Officers of this Corporation and the Board of Directors shall be exempt from liability for the debts of this Corporation.

ARTICLE XIII - DEDICATION AND DISSOLUTION OF ASSETS

All the property and assets of this Corporation are dedicated to charitable and educational purposes meeting the requirements for exemption provided by Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of said property or assets shall inure to the benefit of any Director or Officer of this Corporation or to the benefit of any private individual. However, reasonable compensation may be paid to employees or consultants for services rendered to or for the Corporation affecting one or more of its purposes.

Upon the dissolution, winding up or abandonment of the Corporation, the Directors of the Corporation shall, after payment, or provision for payment, of all debts and liabilities of this Corporation, dispose of all assets of the Corporation to such an organization or organizations as the Directors choose which are organized and operated exclusively for charitable or educational purposes as shall at the time have established tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986 as amended.

ARTICLE XV

Amendments to these Article of Incorporation may be adopted only by the Board of Directors of the Corporation acting in accordance with law and pursuant to the Bylaws of the Corporation.

IN FURTHERANCE THEREOF, the foregoing amendment of the Articles of Incorporation was adopted by the Board of Directors of the Corporation on November 20, 1997, in the manner prescribed by section 607.1003, Florida Statutes. There are no members or members entitled to vote on the amendment.
